**Orderly purchasing:** Ability to gather and provide enough information for selected marketing territories, able to forecast and ability to by from Crown Iran in accordance to the plan.

2- General terms of the Corporation, Exhibitions, Department stores, Warehouse and ...

**Franchisee Rules and Conditions:** Full ownership, convenience access, viewable, presence in main distributing markets within your territory, have stores in main streets or squares.

**Commercial Installations and advertisement:** Stores must be clean and organized at all time with adequate interior installations, having proper sign at front of each store, wear clean and suitable uniforms and clothing all the time.

**Warehouse:** Must have safe and secure storage with top roof and lack of corrosive substances or occupiers, equipped with fire extinguishing system, fire extinguishers, appropriate and organized merchandizing in order to prevent accidents and damages, having inventory control software and hardware, invoicing and issuing batches for removed merchandise.

**Customer Service Management:** Must be well spoken and ethical, friendly, get regular feedback, be a good listener identify and anticipate needs, make customers feel important and appreciated, have adequate customer relations management system "CRM" and have access to Internet and fax all the time.

## **B-** Operations Steps:

1- Franchisee request, work history, copies of your first and last professional licenses, Titles along with any modifications, if any, provide us with 5 different samples of exterior and interior designs of your favorite store, photos of storages along with applicants photo and copies of his- birth certificate and personal Identification card, previous dealership permits or related brands. 2-Documents review: Upon receipt of the documents, they will be examined by our sales and marketing department specialists and after preliminary approval, for further investigation and to complete the application and licensing process will be forwarded to top management team for evaluation and final decision making.

3-Sales department evaluation: After complete review and Executive's approval, your franchisee has been approved and you will be issued a company identification number.
